

**CITY OF WASILLA  
RESOLUTION SERIAL NO. 99-27**

**A RESOLUTION OF THE CITY OF WASILLA, ALASKA REPEALING  
COUNCIL RESOLUTION W82-S-3, AND DETERMINING ON AND OFF-SITE  
ASSESSMENT CHARGES FOR WATER MAIN EXTENSION AGREEMENTS  
BY PRIVATE DEVELOPERS, OR WATER MAIN EXTENSIONS BY THE CITY.**

WHEREAS, WMC 5.10.190(C) provides for payment in-lieu of offsite assessment charges to be paid by private developers desiring to extend water mains, and requires that such payments shall be determined by resolution of the City Council:

NOW THEREFORE BE IT RESOLVED that:

- (1) City of Wasilla Resolution No. W82-S-3 is hereby repealed.
- (2) The amount of payment in-lieu of off-site assessment within the boundary of Assessment District 78-1, as provided for and defined in WMC 5.10.190(C), shall be \$0.01853554 per square foot of the developers property adjoining such water main extension to a maximum depth of 150 feet.
- (3) The amount of payment in-lieu of offsite assessment for areas inside, outside or adjacent to the Wasilla Water Service Area, as provided for and defined in WMC 5.10.190(C), either installed by a private developer or by the city, shall be as shown on Table "A" below, and shall increase at an automatic rate of 2 percent per calendar year.
- (4) The amount of payment in-lieu of onsite assessment for areas inside, outside or adjacent to the Wasilla Water Service Area where the extension has been provided by the city, shall be as shown on Table "A" below, and shall increase at an automatic rate of 2 percent per calendar year.


