**A RESOLUTION OF THE WASILLA CITY COUNCIL RENAMING A PORTION OF
GLENWOOD AVENUE TO RILEY AVENUE.**

WHEREAS, the Palmer-Wasilla Highway Extension project will separate Glenwood Avenue into two different segments; and,

WHEREAS, the Wasilla Planning Commission (WPC) held a public hearing on April 13, 1999 to hear public testimony regarding the proposed road renaming; and

WHEREAS, the proposed street name complies with WMC 17.01.010; and,

WHEREAS, in compliance with WMC 17.01.013 (D), the Matanuska-Susitna Borough has provided a letter of no conflict to the proposed road name; and

WHEREAS, the Wasilla Planning Commission Resolution No. 99-05A passed on April 13, 1999 and WCC Resolution Serial No. 99-12 passed on May 10, 1999, supporting the renaming of this portion of Glenwood Avenue east of Knik Goose Bay Road to coincide with the completion of the Palmer- Wasilla Highway Extension; and

WHEREAS, WPC Resolution No. 00-24 passed on September 12, 2000 recommending that a portion of Glenwood Avenue be renamed to Riley Avenue, prior to the completion of the Palmer-Wasilla Highway extension; and

NOW THEREFORE BE IT RESOLVED, that the Wasilla City Council rename East Glenwood Avenue, East of the longitudinal section line, East Riley Avenue and West Glenwood Avenue be renamed, West of the longitudinal section line, West Riley Avenue;

BE IT FURTHER RESOLVED, that the Wasilla City Council Resolution Serial No. 99-12 is repealed; and


BE IT FURTHER RESOLVED, that the Public Works Department will advertise in a local newspaper and formal notice sent to the Matanuska-Susitna Borough and the United States Postal Service of this street name change a minimum of 30 days to the changing of street signs.



WHEREAS, the Wasilla Planning Commission Resolution No. 99-05(A) recommends to the Wasilla City Council that East Glenwood Avenue be renamed, East of the longitudinal section line, East Riley Avenue and West Glenwood Avenue be renamed, West of the longitudinal section line, West Riley Avenue.


NOW THEREFORE BE IT RESOLVED, that the Wasilla City Council rename East Glenwood Avenue, East of the longitudinal section line, East Riley Avenue and West Glenwood Avenue be renamed, West of the longitudinal section line, West Riley Avenue;

BE IT FURTHER RESOLVED, that the rename coincide with the completion of the Palmer-Wasilla Highway Extension; and

BE IT FURTHER RESOLVED, that the Public Works Department will advertise in a local newspaper and formal notice sent to the Matanuska-Susitna Borough and the United States Postal Service of this street name change a minimum of 30 days prior to the opening of the Palmer-Wasilla Highway Extension for through traffic.
