City of Wasilla

Description of Existing Problem(s)

The City of Wasilla's Police Department currently has two in-car video systems. One works and the other does not. The technicians who have worked on the two systems have advised the Chief that they need to be replaced. These two systems are at least five years old and are not compatible with the newer technologies. Over eight in-car video systems are needed in the City of Wasilla.

The City of Wasilla has no surveillance systems for the police department or for the areas of the city where there are periodic criminal problems.

The Wasilla Police Department's handheld radios are no longer manufactured and certain parts can no longer be acquired for them. According to the Motorola Company, after the year 2006, no parts will be available. As a result of this poor equipment, almost every day when there are radio problems it is necessary for one officer to go and check on another. Currently, the department has no spare radios for the officers and reserve officers have to work without radios. As a result, it necessary to always pair these officers with an officer who has a radio. The Wasilla Police Department needs seventeen radios to resolve this problem.

Project Goals And Objectives

The goals and objectives are to

- increase officer safety;
- · reduce criminal activity; and
- increase investigation quality.

Implementation Plans and Planned Crime Prevention

The Wasilla Police Department plans to place the surveillance systems in three places. One in the interview room in order have evidence available for the district attorney and the court which has both audio and video information. One surveillance camera will be placed at the City's new park to help stop vandalism and deter other crimes. The other outdoor surveillance system will be placed on the new police building itself to observe the highest traffic accident intersection in the City of Wasilla. This will also help in capturing traffic pattern to reflect the problems being experienced as a result of the community's rapid rate of growth and the creation of one of the busiest intersections outside of the State's largest city which is coming about due to the rebuilding of the Parks Highway through the City of Wasilla.

Although seventeen handheld radios are needed to fully equip the department's commissioned staffing level, the ten radios being requested through this funding source will go to patrol officers where officer safety is the greatest issue.

Evaluation Plan

Evaluation activities will consist of a comparison in the number of criminal activity incidents reported, the number initiated by the police, and the number of law enforcement investigation cases accepted for prosecution before the Wasilla Police Department obtained these equipment items and after receipt and use of the equipment.

Officer safety will be assessed during the follow-up period and the number of times that officers need to go to another officer's location to check on the other officer will be compared to the number currently taking place.

Budget Narrative

All equipment items, installation and programming costs will be obtained through an open-competitive bidding process. When possible, efforts will be made to "piggy back" with state procurement efforts for these items.
