A RESOLUTION OF THE CITY OF WASILLA TRANSFERING FUNDS WITHIN AN ACCOUNTING FUND AND EXTENDING THE PARKS AND PROPERTY TECHNICIAN I POSITION 804-2 FROM SEASONAL FULL-TIME TO REGULAR FULL-TIME.

WHEREAS, the Parks and Property Technician I, Position 804-2 is currently a

seasonal (nine month) full-time position where the incumbent is laid off in the winter

season.

WHEREAS, the workload is increasing and this position is needed to support

several activities during the winter months. The activities include ice rink maintenance,

snow removal from walkways and bike paths, hanging winter banners and Christmas

lights, and performing building maintenance including painting, changing lights, fixing

toilets and sinks and other related maintenance.

WHEREAS, this position is particularly effective because the incumbent

oversees the work of inmates from the Point McKenzie Rehabilitation Project. And over

the past two years, this program has provided thousand of dollars worth of work to the

citizens of the City of Wasilla. By extending the program year-round, the city can realize

even greater savings.

NOW THEREFORE BE IT RESOLVED by the Wasilla City Council that the

Parks and Property Technician I Position 804-2 be upgraded from seasonal full-time

(nine months) to regular full- time (12 months) status.
