**SUMMARY STATEMENT:** This resolution combines FAA grant funds that were split to purchase an adjacent parcel for airport improvements. Subsequently, the property purchase was found not cost effective and it was abandoned. FAA has authorized the balance of funding be used for onsite apron improvements. This resolution adjusts both the revenue account and expenditure account. The expenditure account adjustment (\$1,182,000) includes both the City funded portion (\$82,000) and the FAA Grant portion (\$1,100,000); and the revenue account adjustment reflects the FAA Grant portion only.
