WHEREAS, the professional who drafted the plat of Phase II, Mission Hills Subdivision inadvertently misspelled the name of golf legend Lanny Wadkins; and

WHEREAS, all streets within the Mission Hills Subdivision are named after famous golfing professionals; and

WHEREAS, renaming N. Larry Wadkins Place to N. Lanny Wadkins Place is in keeping with the established theme of the subdivision and all other streets within the subdivision; and

WHEREAS, the City Planning Commission unanimously approved WPC Resolution Serial Number 04-18, after conducting a public hearing on June 24, 2004 in accordance with WMC 12.08.030(B); and

WHEREAS, WMC 12.08.010, requires written approval from the Matanuska-Susitna Borough. MSB Platting Division commented on June 10, 2004, "...no problem with the request;" and

NOW THEREFORE BE IT RESOLVED, that the Wasilla City Council rename an existing City Street, approximately 0.11 miles in length located between N. Sam Snead

Loop and N. Lee Travino Drive, Mission Hills Phase II Subdivision, from N. Larry Wadkins Place to N. Lanny Wadkins Place; and

BE IT FURTHER RESOLVED, that the Public Works Department will facilitate publishing this name change in a newspaper of general circulation in the city, send formal notice to the four residents addressed off of N. Larry Wadkins Place, send official notice to the Matanuska-Susitna Borough, and the United States Post Office a minimum of 30-days before the name change is effective.
