prioritizing projects; and

WHEREAS, a CIP schedule, project review criteria and recommendation

process, community budgeting goals, and public comments have been evaluated and

incorporated into a CIP process; and

WHEREAS, it is in the best interest of the residents of the City of Wasilla to

consider short and long range capital improvements that are linked to the City's fiscal

plan and adopted comprehensive plan.

CIP as a budgeting tool

A CIP does not appropriate funds. It functions as a budgeting and planning tool, supporting the actual appropriations that are made through adoption of the annual budget. The City's Financial Policies contain eight related to capital improvements:

▶ The City will make all capital improvements in accordance with an adopted capital improvements program.

CIP Categories

The CIP is organized around several project categories. These categories include:

- Buildings
- ▶ Equipment
- ▶ Parks & Recreation
- Transportation (Roads, Vehicles, Airport)
- Utilities

The CIP should represent the City of Wasilla' on-going commitment to revitalizing aging infrastructure, and increasing its capacity to provide enhanced programs and services to the community.

Description of Major Funding Sources for CIP

General Fund

Unrestricted fund used to support city operations, including City Council, Administrative Services, Finance, General Services, Police, non-Departmental and capital projects. General Fund revenue sources include: 0.4 mill property tax; 2.5% sales tax; franchise fees; business license; permits and fees; and interest earnings.

Capital Project Funds are funds set aside from the City's General Fund for the acquisition and/or construction of major capital facilities and equipment.

Enterprise Funds

Utility Airport Multi-Use Sports Complex

Grant Funding

Funding for CIP projects is requested from the State and from various federal agencies each year. The CIP provides the framework for these grant requests.

SUMMARY STATEMENT:

Section 2.60.010 of the Wasilla Municipal Code requires that the Planning Commission review capital projects on an annual basis and forward their recommendations to the City Council.

The Planning Commission asked that a written description of the CIP process and a schedule be provided for them that would guide them in meeting the Code's requirements. The Commission also asked for the development of specific criteria that they could use to prioritize projects before they were forwarded to the Council.

The draft CIP process and review criteria were developed with input from the City's Department directors and presented to the Planning Commission for their consideration.
