WHEREAS, the City of Wasilla is eligible for a grant allocation for State Fiscal Year (FY) 2005 under AS 37.06 as set forth in 3 AAC 154.030 and 3 AAC 155.030, and


WHEREAS, a prioritized list of projects and supporting information must be submitted if funding is requested by the community under the Capital Project Matching Grant Program as required in AS 37.06.010 and AS 37.06.020, and

WHEREAS, the City of Wasilla must contribute a local share to the cost of each project under the Capital Project Matching Grant Program as required in AS 37.06.030.

NOW, THEREFORE, BE IT RESOLVED by the Wasilla City Council that the City of Wasilla endorses Bumpus Ballfield and Recreation Complex Improvements as the number one priority for this capital funding program and in the "Priority Projects" application form and requests grant funding under AS 37.06 in the amount of \$6,096.00 for said project and agrees to provide the local share for the project in the amount of \$3,904.00 as identified in the "Priority Projects" form, and as required under AS 37.06.

This resolution shall take effect upon adoption by the Wasilla City Council.






**SUMMARY STATEMENT:** This agreement allows the City to receive \$6,096 in State Capital Matching Grant funding this fiscal year. The City match is \$3,904. The grant funding from this program has been used for Bumpus Ballfield and Recreation Complex improvements as well as improvements for Iditapark over the past 4 years. With Iditapark nearing completion, the administration is proposing to use this grant for a new soccer field at the Bumpus Ballfield complex. The City currently has the necessary match funding in place for this grant in the Bumpus Recreation Complex account 110-4520-452.45-18.
