SUMMARY STATEMENT: This resolution authorizes the mayor to execute a 20-year lease with MASCOT for their new transit building. This authority is needed as a condition of MASCOT receiving Rasmuson grant funding in the amount of \$200,000. This project is being funded 80 percent by Federal Transit Administration (FTA) grant funds with the Rasmuson funding needed to meet the FTA match requirements. The City will administer the grant, as required by FTA, and the City will own the building. However, MASCOT will be responsible are all operating costs including insurance.

Tax parcel D9 is located adjacent to the Wasilla Assembly of God, where a portion is being sold to the church, another portion was designated for use by MASCOT in City Council Resolution 03-39, and the remainder is being held in reserve for a future City snow storage site.
