WHEREAS, the City of Wasilla wishes to receive a Justice Assistance Grant from the United States Department of Justice; and


WHEREAS, the City of Wasilla requested a letter of agreement from the Matanuska-Susitna Borough relinquishing claim or interest in the grant funding; and
