SUMMARY STATEMENT: The administration has negotiated a contract amendment with Pruhs Corporation who has the current roads paving contract to pave 2,000 feet of bike path in Iditapark in the amount of \$39,500. There is currently available \$30,000 for paving bike paths, and an additional \$10,000 is needed to complete this project.

There is a balance of funding available from the S. Mack Drive road paving and bike path project in the amount of \$58,415. The administration is seeking approval to transfer \$10,000 of this balance to the Iditapark bike path.

RECOMMENDED ACTION: Approve the Resolution that authorizes the transfer of funding in the amount of \$10,000 for the bike path.

WHEREAS, \$30,000 of funding has been budgeted and is available for bike paths, and

WHEREAS, the City has negotiated a proposal with the roads paving contractor, Pruhs Corporation, to pave 2,000 feet of bike path in Iditapark in the amount of \$39,500; and

WHEREAS, 2,000 feet of bike path will tie in the bike path at the Garden of Refection to the amphitheater stage, to the newly constructed pedestrian bridge, to the Wonderland Parking lot; and

WHEREAS, additional funding is needed to complete the paved bike path loop on the south side of Iditapark as described above.
