and prepare for construction in 2007.


NOW THEREFORE BE IT RESOLVED by the Wasilla City Council that funds be





**SUMMARY STATEMENT:** This resolution authorizes the transfer of funds within an accounting fund for the upgrade of Crusey Street and Lucas Road. Crusey Street is proposed to be expanded to 4 lanes with a middle turn lane. Lucas Road will remain a 2-lane facility, however, it will be constructed with wider shoulders, improved grades, and a bike path from Spruce Avenue to the Parks Highway. The City Council approved Resolution Serial Number 04-02 to authorize the City's participation in the amount of 5 percent to accelerate the projects on the State Transportation Improvement Program (STIP) list. These projects will be constructed by the Alaska Department of Transportation with 95 percent funding from State and Federal sources.

**RECOMMENDED ACTION:** Approve Resolution Serial No. 06-01 that authorizes the transfer of funds within an accounting fund in the amount of \$48,010 for the City's 5 percent match with the Alaska Department of Transportation for the upgrade of Crusey Street and Lucas Road.
