WHEREAS, the Alaska Department of Transportation and Public Facilities requires a management agreement be executed between the City and the Borough before federal funds can be authorized for the Wasilla to Big Lake Trail; and

WHEREAS, an agreement has been drafted by both City and Borough staff that meets the State's requirements to receive up to \$500,000 in federal funding; and


WHEREAS, the funding will be used for pre-design engineering and an environmental review to ensure the selected route will have the least amount of environmental impact.

NOW THEREFORE BE IT RESOLVED, by the Wasilla City Council, that the Mayor is authorized to execute a cooperative management agreement with the Matanuska-Susitna Borough to obtain \$500,000 in federal funding for the Wasilla to Big Lake Multi-purpose Trail.





**SUMMARY STATEMENT:** The Alaska Department of Transportation and Public Facilities (ADOT/PF) requires a management agreement be executed between the City and Borough before federal funds can be authorized for the Wasilla to Big Lake Trail. The attached agreement has been prepared by both the Borough and City staff to meet the requirements of ADOT/PF to receive \$500,000 in federal funding. The agreement allows the City to take the lead in the project and ensure the Borough will have an active role in each phase of the project. The funding will be used for pre-design engineering and an environmental review to ensure the selected route will have the least amount of environmental impact.
