
WHEREAS, U.S. Congress has appropriated funding for paving City roads in the amount of \$1 million, and

NOW THEREFORE BE IT RESOLVED that the Wasilla City Council authorizes the Mayor to execute a memorandum of agreement with the State of Alaska Department of Transportation and Public Facilities to receive \$1 million in federal funding for Wasilla Gravel Road Paving.




**SUMMARY STATEMENT:** This agreement has been prepared by the Alaska Department of Transportation and Public Facilities (ADOT/PF) to receive a federal earmark for paving gravel roads in the City. ADOT/PF will administer the funding and ensure that the project meets all federal requirements. The agreement contains Federal Highway Administration (FHWA) criteria that are necessary to receive the funding. This funding will be used to continue strip paving collector roads in the City.
