




SUMMARY STATEMENT: This resolution authorizes the Mayor to execute a maintenance agreement with the Alaska Department of Transportation and Public Facilities for landscaping and storm drain improvements that will be constructed by the State as part of the Parks Highway Improvements. The fiscal impact will be realized in FY08 within the parks and recreation budget for watering landscaping and in FY09 within the roads maintenance budget for cleaning manholes. The administration has been working with the state on long-range storm drain management. The City will need to utilize the State's storm drain system in the future to accept new storm drains from City streets. Taking over storm drain maintenance will allow city use of the storm drains.

RECOMMENDED ACTION: Council is requested to adopt this resolution that authorizes the Mayor to execute a maintenance agreement with the Alaska Department of Transportation and Public Facilities for landscaping and storm drain improvements that will be constructed by the State as part of the Parks Highway Improvements.
