SUMMARY STATEMENT: This agreement allows the city to receive federal funding for paving in the amount of \$855,000. The City match requirement is \$84,874 that has been budgeted for in FY07 and FY08. Appendix "A" of the agreement shows the roads intended to be paved. This funding is intended for non-LID areas. The City will be receiving \$1 million in state funding next year that will be available for LID areas. The conditions in the agreement are required by the Federal Highway Administration to receive federal funding.
