SUMMARY STATEMENT:

Mr. Patterson, owner of PC Express, has made an offer to settle a delinquent sales tax claim owed to the City of Wasilla. Mr. Paterson owes the City \$13,142.30 broken down as follows:

Mr. Patterson has offered to pay the City \$10,000 in full satisfaction of the City's claim against it for the delinquent sales tax, penalties and interest owed based on disputing the validity of the estimated tax assessment penalties assessed against it.

Based on analyzing the facts surrounding the disputed sales tax case, the probability of collecting the total amount due, the potential cost of collection and the fact that the City will receive from the settlement offer all sales tax, interest and delinquent pay penalties owed to the City, the Finance Director and City Attorney recommends that the Council accept Mr. Patterson's offer.
