SUMMARY STATEMENT: The City obtained federal funds, which have been made available through the Alaska Department of Transportation (DOT), to develop a pilot project to demonstrate the effectiveness of next generation public safety technology, specifically a wideband multimedia mobile communications system. The project involves the development of this technology on a regional basis to enhance the ability of emergency responders as well as transportation and public works officials. The City secured regional licensing for the newly allocated 4.9 GHz spectrum dedicated to public safety use and intends to develop a 4.9 GHz mesh network. DOT has an interest in this project in order to share the communications network in this area for intelligent transportation systems related projects. DOT will provide the ten (10) percent match for the federal funds and will provide project oversight.

RECOMMENDED ACTION: To adopt Resolution Serial No. 07-31 that authorizes the Mayor to execute a grant agreement with the Department of Transportation in the amount of \$4,586,918 for the Wasilla Wideband Multimedia Mobile Emergency Communications Pilot.
