SUMMARY STATEMENT: Each year the Matanuska-Susitna Borough has a Tax and LID Foreclosure Sale where property is made available to purchase through a sealed bid process. One of the lots listed in the sale is Lot 37, Buena Vista Addition #1. This lot is adjacent to a lot that the city already owns. Purchasing this lot would double the amount of square footage from 13,000 to approximately 26,000 square feet. These two lots are located across the street from an easement that leads to Lake Lucille. The Wasilla Parks and Recreation Commission has recommended to the Administration that the purchase would be in the best interest of the City and the property coupled with the property already owned by the City could become a valuable piece of park land in the future. The City is also in the middle of updating its Parks Master Plan and once that is complete, this land could be identified for a specific purpose.

The recommendation of Administration is to purchase this land and retain it for future public purposes.
