A. BICYCLE GIVEAWAY PILOT PROGRAM UPDATE:

The Transportation and Mobility Commission received an update by Paige Portwood, Associate Planner, on the Bicycle Giveaway Pilot Program, including estimated bike utilization metrics and the program's general impacts on the participants' transportation mode behavior.

Kevin Burton, West Hollywood Bicycle Coalition, spoke in favor of the program and made suggestions for the program.

The Commission spoke in support of the program and emphasized the importance of the addition of necessary equipment be added in the giveaway for the program.

The Commission discussed different avenues for participation selection and disqualifications.

The Commission inquired about the program's online reporting process results and possible alternatives.

The Commission discussed possibly offering incentives for the program and/or applying fees to the program.

The Commission spoke on possible collaborations with other businesses to promote the program and education on bicycle infrastructure.

The Commission inquired about complaints for the program and the process for how the complaints are submitted to the City.

The Commission inquired about size parameters for the PDD's.

The Commission inquired if revenue is applied to the PDD's in the future, that portion of those funds be applied to improving sidewalks.
