# G. PUBLIC HEARING

10/25/23-2. Consideration of a Master Use Permit Amendment to allow extended hours of

operation for an existing medical office use (Suite#150) within an existing commercial building located at 1000 North Sepulveda Boulevard, and making an environmental determination for the project in accordance with the California

Environmental Quality Act.

**Commissioner Hackett** announced that she is recusing herself on this item and subsequently left Council Chambers.

Chair Tokashiki announced the item and called for a staff report.

**Director Mirzakhanian** introduced **Associate Planner Tari Kuvhenguhwa** who presented the staff report, summarizing the proposal, providing a detailed analysis and concluding with a recommendation that the Commission conduct a public hearing and adopt the draft resolution approving the Master Use Permit Amendment and a determination of exemption pursuant to CEQA.

**Associate Planner Kuvhenguhwa** also noted three late communications received in support of the application which have been posted to the agenda page and provided to the Commission: Adam Bassuk, Simm's Restaurant Group; George Apostol, project site property owner; and David Archer, Manhattan Beach Chamber of Commerce.

Chair Tokashiki invited questions from the Commission; seeing none, the Chair invited public comment.

The following persons addressed the Commission:

**Kevin Kozal**, representing Sollis Health, stated that the applicant fully supports the staff report and accepts all proposed conditions of approval. He further stated that, in researching the existing 2007 entitlement, he was unable to find a reasoning for the restricted hours of operation.

**Dr. Scott Braunstein**, national medical director, Sollis Health, provided a presentation on the operational characteristics of Sollis Health's business model. He stated that Sollis Health provides unique, member-based acute health care with an intentionally low patient volume. Services are provided both in-person and as tele-health, and include urgent care and concierge medical services. The request for expanded hours would allow Sollis to provide medical service in a manner and at times consistent with their other facilities.

Seeing no further speakers, Chair Tokashiki opened the floor for Commission discussion.

Commissioner Dillavou stated he feels that this is a great use and a type to be encouraged in the city.

There being no further discussion, Chair Tokashiki called for a motion; it was moved and seconded (Dillavou/Ungoco) that the Commission adopt the draft Resolution, approving the Master Use Permit Amendment for 1000 No. Sepulveda Boulevard, Suite 150, and making a determination of exemption pursuant to CEQA.

I. DIRECTOR'S ITEMS – Update on previous Commission projects

Director Mirzakhanian provided the following updates:

1. Historic Preservation Ordinance Amendment: On October 17, the City Council introduced and held

- a first reading of the draft ordinance. The draft ordinance will go back to City Council for a second reading and adoption on November 7, 2023, and become effective 30 days thereafter.
- 2. 229 13<sup>th</sup> Street Use Permit: The Commission's decision of approval for a new commercial building was received and filed by City Council on October 17, 2023. The appeal period will expire on October 26<sup>th</sup> at 5:00 p.m.. To date, no appeals have been filed.

# J. PLANNING COMMISSION ITEMS

Commissioner Ungoco provided an update on the October 24, 2023, Outdoor Dining Task Force meeting. Director Mirzakhanian informed the Commission that the Task Force's work efforts are presented to the City Council on an ongoing basis, and ultimately the Task Force's final recommendations will be presented to the Planning Commission and Parking and Public Improvement Commission for review and recommendation to the City Council for a decision. The City Council's decision will then be submitted to the Coastal Commission.
